

 - (iv) by a fourth deed of variation dated June 21, 2019, recording the resignation of Jayesh Dhanvantkumar Sanghrajka from the Board of Trustees
 - (v) by a fifth deed of variation dated October 14, 2020, recording the appointment of Jayesh Dhavantkumar Sanghrajka, Shamita Chatterjee and Krishnamurthy Shankar as members of the Board of Trustees of Infosys Employee Benefits Trust
 - (vi) by a sixth deed of variation dated October 14, 2020, recording the resignation of Binod Rangadore Hampapur and Richard Lobo from the Board of Trustees.
 - (vii) by a seventh deed of variation dated October 13, 2022, recording the resignation of Sunil Kumar Dhareshwar and appointment of Dhiraj Sethi on the Board of Trustees.
 - (viii) by a eight deed of variation dated April 22, 2024, recording the resignation of Jayesh Dhavantkumar Sanghrajka and Dhiraj Sethi and appointment of Deepak Bhalla and Rajesh Kini M on the Board of Trustees.

- (C) The Board of Trustees now proposes the appointment of Gopalakrishnan Ramachandran aged 43 years, residing at C-204, Atulya, R K Township, Yerandhalli, Jigni Link Road, Bangalore-560099, Karnataka as a member of the Board of Trustees effective July 22, 2024 and record the resignation of Rajesh Kini M as a Trustee effective July 5, 2024 by way of this Ninth deed of variation.
- (D) Pursuant to the terms of Clause 32 of the Deed and the resolution dated July 18, 2024 of the Board of Trustees, the Board of Trustees has accorded its approval for the amending the Deed. The Board of Trustees is now desirous of entering into this ninth deed of variation to effect the amendments in the Deed.


